PROCEDURES FOR EQUIPMENT REMOVAL

1. All Riggers/Buyer's must present authorized Blackbird personnel with an original insurance certificate in the amount of at least \$2,000,000.00 prior to commencing any removal activities (see attached sheet). 2. Should any pits, floor bolts or hazard of any type exist after removal of equipment, it is the responsibility and cost of the buyer to guard these areas using generally accepted safety practices, such as safety tapes, pipes or bars welded in place, or suitable safety barrier, acceptable to Blackbird.
